### Air Navigation Restriction in the vicinity of Bray, Co. Wicklow Saturday July 23<sup>rd</sup> & Sunday July 24<sup>th</sup> 2016

A restriction (Temporary Restricted Area) on the flying of aircraft, including small unmanned aircraft as defined in S.I. No. 563 of 2015, shall apply in the vicinity of Bray, Co. Wicklow in the Airspace contained within the under mentioned:

#### TEMPORARY RESTRICTED AREA 1:

**Lateral limits:** Radius of 6.0 NM centred on 53°12'22.6"N, 006°05'29.0"W

**Vertical limits:** SFC to 5000 feet AMSL

**Duration:** The period of the restriction shall be from 1100hrs UTC to 1800hrs UTC on Saturday July 23<sup>rd</sup> & Sunday July 24<sup>th</sup> inclusive

#### TEMPORARY RESTRICTED AREA 2:

**Lateral limits:** Radius of 6.0 NM centred on 53°12'22.6"N, 006°05'29.0"W

**Vertical limits:** 5000 to 6000 feet AMSL

**Duration:** The period of the restriction shall be from 1530hrs UTC to 1700hrs UTC on Saturday July 23<sup>rd</sup> & Sunday July 24<sup>th</sup> inclusive

#### TEMPORARY RESTRICTED AREA 3:

**Lateral limits:** Radius of 6.0 NM centred on 53°12'22.6"N, 006°05'29.0"W

**Vertical limits:** 5000 to 10000 feet AMSL

**Duration:** The period of the restriction shall be from 1230hrs UTC to 1400hrs UTC on Sunday July 24<sup>th</sup>

The purpose of the TRA is to ensure the safety of aircraft operating within the Bray Airshow, within which flight restrictions may apply, and of other Air Traffic operating in the vicinity of Bray in the period cited.

Subject to any decision of the Flight Operations Department of the Irish Aviation Authority to the contrary, the Airspace within the TRA is restricted to use by aircraft authorised by the Airshow Display Director-FIS Frequency 119.500MHz, and in accordance with instructions and conditions established by the Airshow organisers except where Dublin ATC activates and notifies special contingency arrangements, where necessitated, for that portion of the TRA which lies within the Dublin CTR/CTA.

Remotely Piloted Air Systems (RPAS) e.g. drones, operating privately or under Aerial Works Permission may not operate within the TRA without written Permission from the Flight Operations Authority and Event Organisers. RPAS may be subject to seizure by An Garda Síochána as evidence for potential prosecution and in the interest of Aviation Safety.

State Aircraft and Aircraft of the Irish Coastguard Service employed on an operational mission shall be exempt from the restriction.

Any exemptions, alleviations or permissions, granted to Civil General Air Traffic by the Authority, are not valid within this Temporary Restricted Area during the period cited.

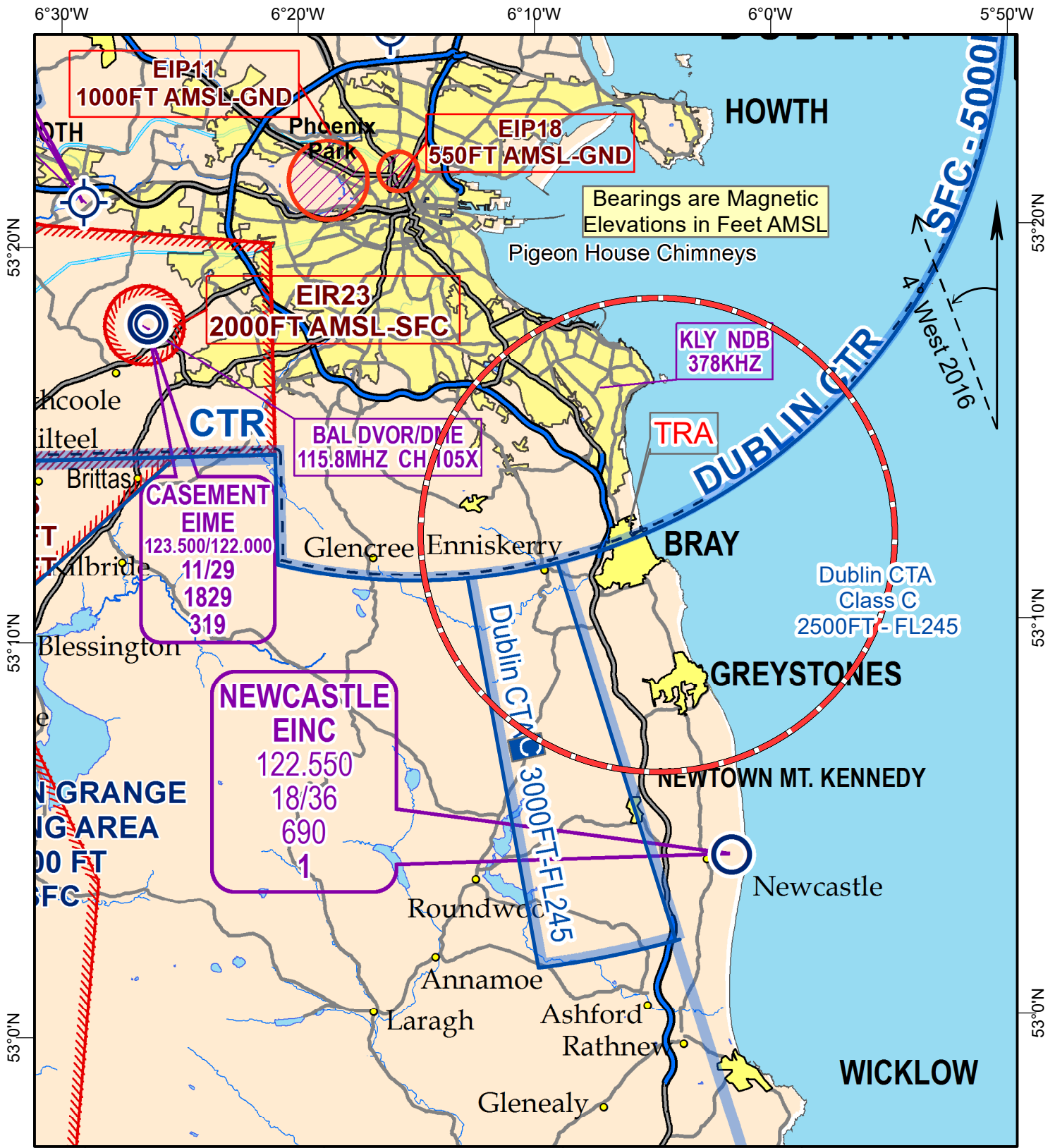
A NOTAM will be issued in due course by the AIS office to notify of the TRA activation.
